A. M. AWAD #77731

Theresa Dennison made a motion that the Board adopt the findings of fact, conclusions of law and recommendations of the Hearing Examiner with the following modifications regarding the license number 77731, issued to M. Awad:

On the basis of the foregoing, the West Virginia Board of Examiners for Registered Professional Nurses (Board) does SUSPEND license number 77731 issued to Maye W. Awad (Awad) for a period of six (6) months. The Board further modifies the Hearing Examiner's recommendation as set out herein. AWAD shall provide the Board proof of completion of the following during the suspension period:

1. At least 30 continuing education credits in ethics;
2. At least 30 continuing education credits in documentation.
3. Completion of the West Virginia Nurse Practice Act module offered by the National Council of State Boards of Nursing.
4. Payment of a \$500 fine and administrative costs.

Following the suspension period and completion of the above, AWAD may submit a reinstatement application, along with the appropriate fee, to the Board. AWAD shall request to appear before the Disciplinary Review Committee (DRC). The DRC shall render a decision regarding AWAD's reinstatement application and probation terms for reinstatement.

Violation of any of the above shall constitute grounds for denial of AWAD's reinstatement.

Teresa Ritchie offered the second. The motion was carried.

7. REVIEW AND CONSIDERATION FOR WV 19CSR3 REQUIREMENTS FOR REGISTRATION AND LICENSURE

Teresa Ritchie made a motion for WV 19CSR3 requirements for registration and licensure. John Martin offered the second. The motion carried.

8. ADJOURN

With no further business before the Board, a motion to adjourn the meeting was made by John Martin. The motion was seconded by Nancy Atkins. The motion carried. Meeting adjourned at 10:33 a.m.
