a. LICENSE # 104449

Leslie Perine made a motion that the Board adopt the findings of fact, conclusions of Law and recommendations of the Hearing Examiner with the following modifications regarding license number 104449, issued to Osei Assibey Bonsu.

On the basis of the foregoing, the West Virginia Board of Registered Nurses (Board) hereby ORDERS that license number 104449, issued to Bonsu be revoked. The Board further modifies the Hearing Examiner's recommendation as set out herein. Should Bonsu desire to seek licensure as a registered professional nurse in West Virginia, he will be required to submit the RN Initial Licensure by Exam Application and successfully complete the licensure examination as any applicant that has never before held a license in this or any other state. Bonsu shall complete all requirements and Instructions set forth in the RN Initial Licensure by Exam Application.

Bonsu shall be required to meet the following terms and conditions prior to submitting the RN Initial Licensure Exam Application:

- a. Bonsu shall attend an accredited school of nursing;
- b. Bonsu shall graduate from an accredited school of nursing; and,
- c. Bonsu shall submit evidence of a valid, verified degree from the accredited school of nursing from which he graduates.

Violation of any of the above shall constitute grounds for denial of Bonsu's RN Initial Licensure by Exam Application

Jason Vanhooose offered the second. The motion carried.

b. LICENSE # 97139

Chad Callen made a motion that the Board adopt the findings of fact, conclusions of Law and recommendations of the Hearing Examiner with the following modifications regarding license number 97139, issued to Joshua Russell.

On the basis of the foregoing, the West Virginia Board of Registered Nurses (Board) hereby ORDERS that license number 97139, issued to Russell be revoked. The Board further modifies the Hearing Examiner's recommendation as set out herein. Should Russell seek to reinstate his license, Russell shall complete a Reinstatement Application (Application) and submit the Application. The reinstatement process will require Russell to submit documentation, satisfactory to the Board, that Russell can safely and competently resume the practice of nursing.

Violation of any of the above shall constitute grounds for denial of Russell's Application.

Leslie Perine offered the second. The motion carried.
