Also, the Board reviewed the program report and response letter on closing a program received September 1, 2016 from Breckinridge School of Nursing and Allied Health at ITT Technical Institute. A motion was made by Teresa Ritchie to accept the program report on closing the program. The second was offered by Doris Burkey. The motion carried.

A motion was made by Teresa Ritchie to rejected the program plan for permanent custody and storage of records for students and graduates and requires the program to identify a method of retrieval of information from the records and transfer of students and records for 13 students who have completed course work but who have not yet graduated. The second was offered by Doris Burkey. The motion carried.

The Board reviewed and considered the letter from Thomas Brouwer, Regulatory Affairs Manager, ITT Educational Services, Inc., received September 12, 2016 notifying the West Virginia Board of Examiners for Registered Professional Nurses that ITT Educational Services, Inc. has discontinued academic operations at all ITT Technical Institute locations located in West Virginia inclusive of the associate degree in nursing program offered at these locations. The letter further reports that the graduation requirement to pass a Health Education System, Inc. (HESI) Exit exam has been removed and all students from the program inception to the current cohort will be notified of the graduation requirement and will be awarded a degree pursuant to the revised graduation requirement. A motion was made by Teresa Ritchie that Board staff send written notice to Breckinridge School of Nursing and Allied Health at ITT Technical Institute that pursuant to WV19CSR1 to include the following:

- 1) Accept the letter from ITT Technical Institute that they have discontinued academic operations of the associate degree in nursing program offered at all West Virginia locations.
- 2) Approve the ITT graduation policy to eliminate the Exit HESI as a graduation requirement; and
- 3) determined the governing organization failed to meet the following closing of a program standards:
  - a. 19-1-7.1 "to advise the Board in writing of the intent to close a nursing education program at least 6 months prior to the planned closing date".
  - b. 19-1-7.2 to "ensure all standards for nursing education program are maintained and all necessary courses are taught until the last student transferred or graduated".
  - c. 19-1-7.3 to "secure and provide for the permanent custody and storage of records of students and graduates. The Board shall be notified of the location and method of retrieving information from these records"; and
  - d. 19-1-7.4 to respond to the Board request to "provide information and plans for the closing of a nursing education program and the transfer of students and records".

Requires the governing organization send a written letter response within 30 days of receipt of this letter outlining a permanent custody and storage of records of students and graduates and the location and methods of retrieving information from these records, and information on the transfer of students and records for students who have not yet graduated or the completed transcripts conferring the associate degree in nursing for these students, and the name of a dean or director who will sign and verify the licensure application including placing the school seal on the licensure application for graduates. The motion was seconded by Doris Burkey. The motion carried.
