**a. REVIEW AND CONSIDERATION OF HEARING EXAMINER
RECOMMENDATION AND TRANSCRIPT FOR LICENSEE #110722**

Tara Hulseley made a motion to adopt the findings of fact, conclusions of law and hearing examiners recommendations and indefinitely REVOKE West Virginia Advanced Practice Registered (APRN) License Number 110722 issued to Beck and Beck's privilege to practice in West Virginia. The Board further modifies the Hearing Examiner's recommendation as set out herein. Should Beck wish to reinstate his APRN license, Beck shall complete with the online APRN Reinstatement Application (Application), submit the Application, along documentation of thirty (30) contact hours of continuing education by a Board approved continuing education provider in each of the following areas: ethics, medication administration and documentation to the Board for review. Beck shall contact the Board and schedule an appointment to appear before the Disciplinary Review Committee (DRC) after he has provided the aforementioned continuing education. The Board must receive the Application and continuing education at least thirty (30) days prior to the scheduled DRC meeting. Following Beck's appearance, the DRC shall render a decision regarding his Reinstatement Application. Violation of any of the above shall constitute grounds for denial of BECK's license. Chad Callen offered the second. No abstentions. No opposition. The motion carried.

7. MISCELLANEOUS


Dr. Painter provided an update on the status of the nurse education legislation.
