Teresa Ritchie made a motion that based on the foregoing, the West Virginia Board of Registered Nurses (Board) hereby indefinitely REVOKES VALERIE CLARK'S privilege to practice in West Virginia and ORDERS the Proposed Consent Agreement entered February 18, 2022, null and void. The Board further modifies the Hearing Examiner's recommendation as set out herein. Should CLARK ever wish to practice registered professional nursing in the state of West Virginia, CLARK must submit an Endorsement Application (Application) and submit all requirements set forth by the Board at the time of submitting the Application. Violation of any of the above shall constitute grounds for denial of CLARK's license.
