1. CALL TO ORDER

The meeting was called to order by Tara Hulsey, Board President, at 12:00 p.m.

2. QUORUM

A quorum was established.

3. REVIEW AND CONSIDERATION OF AGENDA

The Board reviewed the proposed agenda. Jason Vanhooose made a motion to approve the agenda. Chad Callen seconded. The motion carried.

4. REVIEW AND CONSIDERATION OF 19-03 RULE CHANGES FOR 2025 LEGISLATIVE SESSION

Teresa Ritchie made a motion to approve the language changes to 19.3.3.2.a by adding "until the date the Board receives notice from the National Council Licensure Examination (NCLEX) that the applicant has achieved a passing score on the applicant's licensing examination" and removing "until the date the applicant's licensing examination results are released to the office of the board by the National Council Licensure Examination (NCLES-RN)" AND by removing 19.3.5.1 of the section.

5. EXECUTIVE SESSION FOR REVIEW AND CONSIDERATION OF FINAL ORDERS

Jason Vanhooose made a motion for the Board to convene in Executive Session. Chad Callen offered the second. The motion carried. The Board went into Executive Session.

a. REVIEW AND CONSIDERATION OF HEARING EXAMINER RECOMMENDATION AND TRANSCRIPT FOR WEST VIRGINIA LICENSEE #22533

Tara Halsey made a motion to adopt the findings of fact, conclusions of law and hearing examiners recommendations and on the basis of the foregoing, the West Virginia Board of Registered Nurses (Board) hereby revokes license number 22533 issued to Stephens for at least two (2) years, effective August 21, 2024. The Board further modifies the Hearing Examiner's recommendation as set out herein. After the two (2) year period and at least thirty (30) days prior

to petitioning the Board for reinstatement of Stephen's license, the Board ORDERS Stephens to submit to a rule out substance abuse assessment by a Board approved Master Addictions Counselor (MAC) or Advanced Alcohol Drug Counselor (AADC). Stephens shall request that a complete copy of her Board file, which includes this Final Order, be sent to the MAC or AADC performing Stephens' assessment prior to her assessment. Once Stephens has received the assessment and has been deemed safe to practice by her MAC or AADC. Stephens shall complete a Reinstatement Application (Application) and submit the Application, along with a copy of her assessment to the Board's Disciplinary Review Committee (DRC) for review. Stephens shall contact the Board and schedule an appointment to appear before the DRC after she has provided the above information. Following Stephens' appearance, the DRC shall render a decision regarding her Reinstatement Application.

Violation of any of the above shall constitute grounds for denial of Stephens' license.

**b. REVIEW AND CONSIDERATION OF HEARING EXAMINER
RECOMMENDATION AND TRANSCRIPT FOR WEST VIRGINIA
LICENSEE #70671**

Leslie Perrine made a motion to adopt the findings of fact, conclusions of law and hearing examiners recommendations and on the basis of the foregoing, the West Virginia Board of Registered Nurses (Board) hereby revokes license number 70671 issued to Buckner for at least two (2) years, effective August 21, 2024. The Board further modifies the Hearing Examiner's recommendation as set out herein. After the two (2) year period and at least thirty (30) days prior to petitioning the Board for reinstatement of Buckner's license, the Board ORDERS Buckner to submit to a rule out substance abuse assessment by a Board approved Master Addictions Counselor (MAC) or Advanced Alcohol Drug Counselor (AADC). Buckner shall request that a complete copy of her Board file, which includes this Final Order, be sent to the MAC or AADC performing Buckner's assessment prior to her assessment. Once Buckner has received the assessment and has been deemed safe to practice by her MAC or AADC. Buckner shall complete a Reinstatement Application (Application) and submit the Application, along with a copy of her assessment to the Board's Disciplinary Review Committee (DRC) for review. Buckner shall contact the Board and schedule an appointment to appear before the DRC after she has provided the above information. Following Buckner's appearance, the DRC shall render a decision regarding her Reinstatement Application.

Violation of any of the above shall constitute grounds for denial of Buckner's license.
