a. REVIEW AND CONSIDERATION OF SUMMARY SUSPENSION RELATED TO LICENSEE #113923

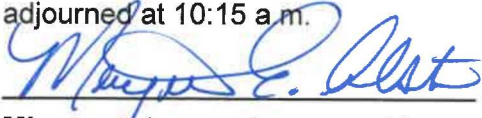
Chad Callen made a motion to issue a summary suspension for Erica Bryd based on the evidence presented. Teresa Ritchie offered the second. The motion carried.
