days prior to the next scheduled Board meeting. The second was offered by Chad Callen. The motion carried.

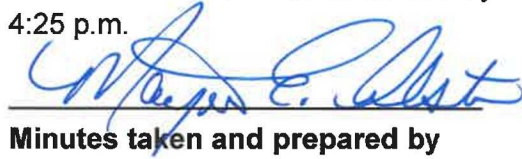
Tara Hulsey and Teresa Ritchie rejoined the meeting at this time.
