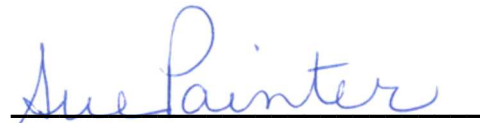
6. MISCELLANEOUS

Higher Education Policy Commission (HEPC) sent a request to the Board for a letter of support for funding for a West Virginia Healthcare Workforce Demand Data Collection System

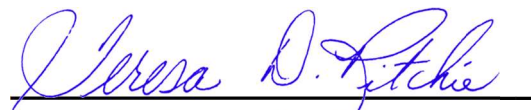
