LICENSEE #49322**

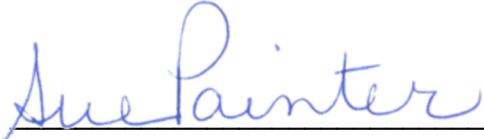
Wanda Marks made a motion to summarily suspend license number 49322. Teresa Ritchie offered the second. The motion carried.

7. MISCELLANEOUS

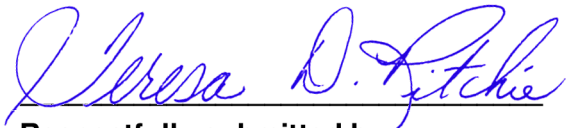
There was no business under this agenda item.
