a. REVIEW AND CONSIDERATION OF HEARING EXAMINER RECOMMENDATION AND TRANSCRIPT FOR L. SMITH VA MSL 01273665

Jason Vanhooose made a motion to adopt the findings of fact, conclusions of law and Hearing Examiners recommendations. And, on the basis of the foregoing, the West Virginia Board of

Registered Nurses (Board) hereby SUSPENDS Smith's multi-state privilege to practice in West Virginia.

Should Smith resume practice as a registered nurse in the state of West Virginia on a multi-state privilege to practice SMITH must notify the Board via certified mail within seven (7) to ten (10) business days.

Should Smith attempt to practice registered professional nursing in the State of West Virginia on a single-state license, she must submit an Endorsement Application (Application) to the Board. Along with the Application SMITH shall submit the following but not limited to; evidence of an unencumbered license in all states that SMITH currently holds or held RN licensure for review. After Smith's Application is deemed complete, Smith shall contact the Board and schedule an appointment to appear before the Board's Disciplinary Review Committee (DRC). The Board must receive the documents at least thirty (30) days prior to the next scheduled DRC meeting. Following Smith's appearance, the DRC shall render a decision regarding her Application.

Violation of any of the above shall constitute grounds for denial of SMITH's Application and/or further action as warranted.

Teresa Ritchie offered the second. No abstentions. No opposition. The motion carried
