She explained that the contract for the Board Nurse Health Program known as WV Restore has been contracted to the WV Pharmacist Recovery Network since December 2015 (one (1) year with 3 (three) option renewal years). The Contract is due to expire on December 14, 2019. She updated the Board of its decision to provide the management and operations of WV Restore within the Board's Operations at the March 8, 2019 meeting.

The Executive Director provided the Board with a brief overview how the Board staff planned to manage the program in the future by submitting RFQ's through the WV Purchasing Division for two separate contracts. One contract for Case Management and Monitoring and a separate contract for Facilitated Peer Support.

She further explained that conferences would be managed by Board staff and would be made available several times throughout the state and to allow interested nurses to attend free of charge.

Also, to provide six (6) Nurse Health Program Recovery Coach Training Programs for approximately seventy (70) Registered Nurses throughout West Virginia.

Lori Chaffins, Nurse Health Outreach Coordinator will continue to speak to groups across the state.
