  - 4. REVIEW AND CONSIDERATION OF RULES TO SUSPENDED DURING A DECLARED EMERGENCY BY THE GOVERNOR OF WEST VIRGINIA
    - A. APPLICANT FOR EXAMINATION EDUCATED IN THE UNITED STATES OR TERRITORIES
      - 1. ELECTRONIC CRIMINAL HISTORY (RULE 19-3-3.1.a.4.)
- 4.A.1 Teresa Ritchie made a motion that pursuant to the Governor's issued State of Emergency Declaration related to the outbreak of the COVID-19 virus in which he delegated authority to state agencies to suspend rules, if strict compliance therewith would in any way prevent, hinder or delay necessary action in coping with the emergency and pursuant to the Governor's Executive Order directing the same. I move the West Virginia Board of Examiners for Registered Professional Nurses (Board) suspend Rule 19-3-3.1.a.4 to permit the waiver of CBC in the Identogo Enrollment Center is closed until the center reopens and another center is not within reasonable distance from the applicant location. When the Center reopens the CCBC needs to be completed. Such suspension shall take effect immediately and shall cease upon the filing of a Notice lifting the suspension or upon the termination of the State of Emergency, whichever occurs first. Such suspension shall take effect immediately and shall cease upon the filing of a Notice lifting the suspension or upon the termination of the State of Emergency, whichever occurs first. Theresa Dennison offered the second. The motion carried.

Such suspension shall take effect immediately and shall cease upon the filing of a Notice lifting the suspension or upon the termination of the State of Emergency, whichever occurs first. Theresa Dennison offered the second. The motion carried

Teresa Ritchie made a motion that pursuant to the Governor's issued State of Emergency Declaration related to the outbreak of the COVID-19 virus in which he delegated authority to state agencies to suspend rules, if strict compliance therewith would in any way prevent, hinder or delay necessary action in coping with the emergency and pursuant to the Governor's Executive Order directing the same, and because these rules have corresponding code, I move the West Virginia Board of Examiners for Registered Professional Nurses (Board) submit the following code sections to the Governor for suspension in whole or in part as follows; W.Va. Code 30-2-7(a) and W.Va. Code 30-1-7(a) permitting the waiver of CE for these topics during the emergency. Such suspension shall take effect immediately and shall cease upon the filing of a Notice lifting the suspension or upon the termination of the State of Emergency, whichever occurs first. Nancy Atkins offered the second. The motion carried.

# 2. TEMPORARY PERMIT (LAW 30-7-6(d)

A.2. Teresa Ritchie made a motion that pursuant to the Governor's issued State of Emergency Declaration related to the outbreak of the COVID-19 virus in which he delegated authority to state agencies to suspend rules, if strict compliance therewith would in any way prevent, hinder or delay necessary action in coping with the emergency and pursuant to the Governor's Executive Order directing the same, and because these rules have corresponding code, I move the West Virginia Board of Examiners for Registered Professional Nurses (Board) submit the following code sections to the Governor for suspension in whole or in part as follows; W.Va. Code 30-7-6(d) to remove the expiration of ninety (90) days. Such suspension shall take effect immediately and shall cease upon the filing of a Notice lifting the suspension or upon the termination of the State of Emergency,

whichever occurs first. Nancy Atkins offered the second. The motion carried.

### B. REINSTATEMENT OF LAPSED, RETIRED OR INACTIVE RN LICENSE 1. CONTINUE EDUCATION (LAW 30-1-7A)

Teresa Ritchie made a motion that pursuant to the Governor's issued State of Emergency Declaration related to the outbreak of the COVID-19 virus in which he delegated authority to state agencies to suspend rules, if strict compliance therewith would in any way prevent, hinder or delay necessary action in coping with the emergency and pursuant to the Governor's Executive Order directing the same, and because these rules have corresponding code, I move the West Virginia Board of Examiners for Registered Professional Nurses (Board) submit the following code sections to the Governor for suspension in whole or in part as follows; W.Va. Code 30-1-7(a) permitting the waiver of CE for these topics during the emergency. Such suspension shall take effect immediately and shall cease upon the filing of a Notice lifting the suspension or upon the termination of the State of Emergency, whichever occurs first. Nancy Atkins offered the second. The motion carried.

# 2. CRIMINAL HISTORY (LAW 30-7F-3)

B.2. Teresa Ritchie made a motion that pursuant to the Governor's issued State of Emergency Declaration related to the outbreak of the COVID-19 virus in which he delegated authority to state agencies to suspend rules, if strict compliance therewith would in any way prevent, hinder or delay necessary action in coping with the emergency and pursuant to the Governor's Executive Order directing the same, and because these rules have corresponding code, I move the West Virginia Board of Examiners for Registered Professional Nurses (Board) submit the following code sections to the Governor for suspension in whole or in part as follows; W.Va. Code 30-7F-3 permitting the waiver of CBC if the Identogo Enrollment Center is closed until the Center reopens and another Center is not within reasonable distance from the application location. Such suspension shall take effect immediately and shall cease upon the filing of a Notice lifting the suspension or upon the termination of the State of Emergency, whichever occurs first. Doris Burkey offered the second. The motion carried.

- 6. REVIEW AND CONSIDERATION OF MODIFICATION OF CONSENT AGREEMENTS OR MONITORING AGREEMENTS WITH THE BOARD ARE REQUIRED TO:
  - A. ATTEND 12 STEP MEETINGS, GROUP COUNSELING SESSIONS AND/OR INDIVIDUAL COUNSELING SESSIONS WILL BE PERMITTED TO DO SO ONLINE OR BY UTILIZING ANY OTHER FORM OF TECHNOLOGY NOT REQUIRING A FACE TO FACE, IN PERSON MEETING.
- 6.A. Doris Burkey made a motion that pursuant to the Governor's issued State of Emergency Declaration related to the outbreak of the COVID-19 virus in which he delegated authority to state agencies to suspend rules, if strict compliance therewith would in any way prevent, hinder or delay necessary action in coping with the emergency and pursuant to the Governor's Executive Order directing the same. I move the West Virginia Board of Examiners for Registered Professional Nurses (Board) approve the licensee to attend 12-step meetings, group counseling sessions and/or individual counseling sessions online or by utilizing and other forms of technology not requiring a face-to-face, in person meeting. Such suspension shall take effect immediately and shall cease upon the filing of a Notice lifting the suspension or upon the termination of the State of Emergency, whichever occurs first. The second was offered by Theresa Dennison. The motions carried.

# B. PRESENT FOR RANDOM DRUG SCREEN

6.B. Teresa Ritchie made a motion that pursuant to the Governor's issued State of Emergency Declaration related to the outbreak of the COVID-19 virus in which he delegated authority to state agencies to suspend rules, if strict compliance therewith would in any way prevent, hinder or delay necessary action in coping with the emergency and pursuant to the Governor's Executive Order directing the same. I move the West Virginia Board of Examiners for Registered Professional Nurses (Board) approve to suspend random drug testing but to continue daily check-ins with Affinity if labs are unavailable during the emergency but restart testing as soon as the labs become available for licencees under a consent agreement. Such suspension shall take effect immediately and shall cease upon the filing of a Notice lifting the suspension or upon the termination of the State of Emergency, whichever occurs first. The second was offered by Nancy Atkins. The motions carried.

- 7. REVIEW AND CONSIDERATION OF REQUEST TO APPROVE SENIOR NURSING STUDENTS WHO HAVE ACCEPTED POSITION AT FACILITIES, COMPLETED GRADUATION REQUIREMENTS OR OTHERWISE COMPETENT, TO PROVIDE ADDITIONAL NURSING CARE DURING A DECLARED EMERGENCY BY GOVERNOR
- 7.B. A discussion ensued. A motion was made by Tara Hulsey to table this topic until meeting scheduled for April 3, 2020. The second was offered by Teresa Ritchie. The motion carried.
