- 9.** The Executive Director provided an update on legislation passed during the 2020 session.

- Senate Bill (SB) 560 will be effective on 5-18-2020. The purpose is to allow Nursing Assistants with specific training to administer medications in nursing homes. These individuals will have to pass a national medication aide certification examination approved by the National Council of State Boards of Nursing (same organization which provides the NCLEX for RNs).
- SB 647 will be effective on 6-5-2020. The purpose of this bill is to permit physician assistants and advanced practice nurse practitioners to issue do not resuscitate orders.
- SB 664 will be effective on 6-4-2020. Updating terminology related to advanced practice registered nurses.
- SB 707 was effective on 3-7-2020. The purpose is a nursing career pathway available to students statewide; setting forth legislative findings; requiring that a nursing career pathway workgroup be convened; charging the workgroup with developing a career pathway to address the unmet need for nursing assistants, licensed practical nurses, registered nurses, and registered nurses with a bachelor's degree in nursing; requiring the nursing career pathway to be made available to students statewide; requiring report to the Legislative Oversight Commission on Education Accountability, as requested, but at least annually, on the progress in implementing the career pathway; and requiring consideration of certain specified ideas in establishing the pathway. Our board has a position on the committee.
- House Bill (HB) was effective from passage and pertained to 19CSR03 and 19CSR15 from the 2019 Legislative Session.
- HB 4417 will be effective on 6-2-2020. The purpose of this bill is to permit different types of continuing education to qualify for completion of the drug diversion continuing education requirements. The Board will consider the impact of this bill in the near future.
- HB 4434 will be effective on 6-1-2020. The purpose of this bill is to have a statewide study and report on the existing health care workforce, as well as the workforce needs of the next 15 years.




- 17.B.** The Board member signed the 2020 WV Executive Branch Confidentiality Agreement.
