The Committee directed staff to respond to Dr. DiChiacchio that the specific policy referenced is beyond the

jurisdiction of this Board as this Board does not regulate the billing practices outlined in his policy. The Committee further reviewed an Arkansas Board of Nursing Position Statement on dermatological procedures by nurses and related research. The Committee noted that Dr. Robin Lewis is quoted in the article as outlining the relevant law in WV pertaining to this practice. It is a recommendation of the Committee that Dr. Lewis create a draft position statement on this issue to be presented for review by the Board at its March Board meeting. 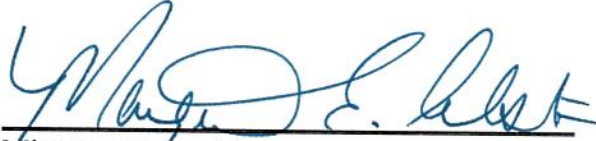
