### **3.A. A. EMERY #59825 -**

**3.A.** Teresa Ritchie made a motion to uphold the summary suspension of license number 59825, issued to Emery. The Board further modifies the Hearing Examiner's recommendation as set out herein. The Board ORDERS Emery to report to WV Restore within five (5) business days of notice of this Order and to fully participate in WV Restore. Emery shall cause a complete copy of her Board file, which includes this Final Order, to be sent to the WV Restore Program and the counselor performing Emery's evaluation through WV Restore before her evaluation. Once Emery has received an evaluation through the WV Restore program and has been deemed safe to practice by WV Restore, Emery shall complete a reinstatement application and submit the application, along with a copy of her evaluation through WV Restore and her WV Restore file to the Board's Disciplinary Review Committee (DRC) for review. Emery shall contact the Board and schedule an appointment to appear before the DRC after she has provided the above information. Following Emery's appearance, the DRC shall render a

decision regarding her reinstatement application. The Board also ORDERS Emery pay a fine and administrative cost in the amount of five hundred dollars and 00/100 (\$500.00). The second was offered by Nancy Atkins. The Motion carried.

**3.B. E. DEBOLT #86245 -**

**3.B.** John Martin made a motion to uphold the summary suspension of license number 86245, issued to Debolt. The Board further modifies the Hearing Examiner's recommendation as set out herein. The Board ORDERS Debolt to report to WV Restore within five (5) business days of notice of this Order and to fully participate in WV Restore. Debolt shall cause a complete copy of her Board file, which includes this Final Order, to be sent to the WV Restore Program and the counselor performing Debolt's evaluation through WV Restore before her evaluation. Once Debolt has received an evaluation through the WV Restore program and has been deemed safe to practice by WV Restore, Debolt shall complete a reinstatement application and submit the application, along with a copy of her evaluation through WV Restore and her WV Restore file to the Board's Disciplinary Review Committee (DRC) for review. Debolt shall contact the Board and schedule an appointment to appear before the DRC after she has provided the above information. Following Debolt's appearance, the DRC shall render a decision regarding her reinstatement application. The Board also ORDERS Debolt pay a fine and administrative cost in the amount of five hundred dollars and 00/100 (\$500.00). The second was offered by Teresa Ritchie. The motion carried.

**3.C. B. FOREMAN #95911 -**

**3.C.** Tara Hulsey made a motion to uphold the summary suspension of license number 95911, issued to Foreman. The Board further modifies the Hearing Examiner's recommendation as set out herein. Foreman is Board ordered to participate in West Virginia Restore. Foreman shall comply with all treatment recommendations mandated by West Virginia Restore within the time frame required by West Virginia Restore. Prior to petitioning for reinstatement Foreman must be deemed safe to practice by West Virginia Restore. Foreman shall submit a Reinstatement Application and submit the application to the Board. Foreman shall contact the Board and schedule an appointment to appear before the Disciplinary Review Committee (DRC) after the Board has received the above information. Following Foreman's appearance, the DRC shall render a decision regarding her reinstatement application. The Board also ORDERS Foreman pay a fine and administrative cost in the amount of five hundred dollars and 00/100 (\$500.00). The second was offered by Nancy Atkins. The motion carried.

**4. REVIEW AND CONSIDERATION OF PROPOSED LEGISLATION**



**5. MISCELLANEOUS**


5. The Board discussed future Special Board Meeting dates to review and consider Hearing Transcripts.
